The world is under great transformation. Globalization has become a trend that is very difficult to resist. The result of it could be some countries or a few special locations receive great benefits, and living standards in those areas are greatly lifted. On the other hand, globalization has also brought many seriously social problems for the world, especially in those underdeveloped and developing countries. Problem of political legitimacy therefore has become a serious one in many countries.

This new world stage contains an imbalance and contradictory structure, and it has generated special concerns among diverse civil society actors on the kinds of social change that are occurring. Although civil society researchers and actors have shown significant advance in attaining more just and inclusive societies, there remain enormous challenges that demand multi-disciplinary approaches and new strategic alliances among the Third Sector and with the market and state sectors. The transforming world not only brings serious changes and challenges, but it probably also carries new opportunities for us. It invites scholars and practitioners to imagine a progressive and alternative future and to exchange their experiences and findings.

Abstracts and Organized Panels

Those wishing to present a paper are invited to submit the abstract before 30 April 2009 to the Center for the Third Sector (333@nccu.edu.tw) by e-mail. To be considered for review, an abstract must reach the following minimum standards:

- (1) There must be a working title that clearly identifies the conference theme being addressed;
- (2) The abstract should summarize research problems, methodology and design, locate the issue within a wider literature, main findings/conclusions of the paper, indicate its relevance to an international audience, and establish its empirical and/or theoretical or practical base;

(3) The abstract should be approximately 500 words in length, but no less than 400 or more than 700 words.

An organized panel submission is a proposal for a coordinated set of papers (usually 3 or 4 in number) all dealing with a particular topic or issue. Please note that panel proposals require an abstract identifying and justifying the theme of the panel as well as a full abstract for each panel paper. Panel proposals that do not include full abstracts and author information for each paper will not be considered. The person submitting the panel proposal must be willing to act as the panel coordinator and ensure that all proposed paper presenters commit to attending the conference.

All submissions satisfying the basic requirements (paper or panel) will be subject to a blind review by three independent reviewers who will not have knowledge of the name of the author or of other reviewers. Paper abstract providers will be notified on July 15 whether their papers are accepted or not. In addition, those planning to organize a PANEL or PANELS must also contact Dr. Shih-Jung Hsu (srshiu@nccu.edu.tw) by 15 April 2009, with title and description of the panel(s), and the names of prospective presenters.

Scholarships

A limited number of scholarships designed to encourage participation of researchers from Asian developing countries, and a limited number of scholarships designed to encourage participation of Ph.D. students. The scholarships provide financial assistance for travel and accommodation. Applicants for scholarships please propose their applications at the same time when they submit their paper abstracts. Applicants will be notified on July 15 whether their applications are accepted or not.
